

New Bremen Title I School-Parent Compact

- Offer conferences with Title One teachers every fall.

- Include a School-Parent Compact which is a written agreement of what school and parents are each responsible for to effectively help students achieve.
- Notify parents of pre-school age children about Child-Find programs.
- Involve parents in an organized, ongoing way through Cardinal Pride which is a parent group.
- Provide parents reasonable access to staff.
- If requested, the school provides parents opportunities to volunteer and participate in their child's class and to observe classroom activities.
- Provide to each parent an individual student report about the performance of their child on the state assessment in at least math, language arts and reading.
- Provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002).
- Provide a survey for parental input and suggestions.
