8. Memorandum of Understanding

Approve a Memorandum of Understanding with the New Bremen Teachers Association to modify Article 9.A.7 - Contract Days-School Calendar-Meetings. This would be effective for the remainder of the 2020-21 school year.

Per the Contract Days-School Calendar-Meetings Article 9.A.7 of the negotiated agreement the Board and the Association agree to the following Memorandum of Understanding for the remainder of 2020-2021 school year.

9.A.7

- 1. Teachers will report to duty from 10:00 am to 3:00 pm on days where school is closed due to inclement weather after 5 calamity days have been used. This will be done for the remainder of the 2020-2021 school year. Lessons will be posted or given to students ahead of time to complete virtually.
- 2. If the teacher is unable to report safely to work, then he/she shall call his/her appropriate supervisor and discuss options to reach a solution. Possible solutions may be (but are not limited to): working from home, make up the time according to an agreement reached and approved by the appropriate supervisor, make arrangements to report to work later and extend the day beyond 3:00 pm, or take a personal day.

The number of days scheduled shall not limit the Districts ability to require additional days worked to ensure compliance with the state minimum number of hours of instruction per year. Teachers will not be required to work more than the 184 days they are contracted to work.

Resolution to expand employment of substitute teachers consistent with Am. Sub. House Bill 409

Pursuant to the authority granted in Section 3 of Amended Substitute House Bill 409 of the 133rd General Assembly, signed by Governor DeWine on or about January 7, 2021, the New Bremen Board of Education authorizes the employment of substitute teachers, as-needed, who do not hold a post-secondary degree, as otherwise required pursuant to Ohio law and regulations, including Ohio Revised Code 3319.226 and 3319.30, Ohio Administrative Code Section 3301-23-44, and/or Board Policy, provided that all other applicable requirements and procedures, including successful completion of a criminal background check and evidence of a non-renewable temporary substitute teaching license issued by the Ohio Department of Education, have been satisfied.

This is a temporary resolution of the New Bremen Board of Education, and the authority granted by this resolution extends from the effective date through June 30, 2021.

[Pursuant to existing O.R.C. 3319.226, the Board should otherwise re-approve other substitutes who are post-secondary degree holders, who are substitute teaching in a subject area

that is not directly related to the subject of the class that the license holder will teach.]
