- 3. The 2022 Fund Drive for the New Bremen Education Foundation was recently completed. There were a total of <u>108</u> scholarships awarded to the 2022 graduates as the result of the New Bremen Education Foundation (NBEF). The one-year NBEF scholarships totaled \$108,713, with an additional \$43,500 in renewable scholarships. In addition to the New Bremen Education Foundation Scholarships, there were also approximately <u>51</u> other scholarships that were either local or regional that were awarded. These scholarships totaled \$50,075.

The total scholarships for the Class of 2022 from all sources totaled \$504,223 for one-year scholarships. The 4-year renewable total from all sources was \$1,573,280.

4. New Bremen Local Schools has adopted and is enforcing a nutrition standards policy that considers the requirements of Ohio Revised Code 3313.814 and governs the types of food and beverages that may be sold on the premises of its school.
